Note : 75% of the amount will be utilised for the laboratory and allied expenditures


25% of the amount will be deposited in the Revenue allowance @ IFB.Hyd

Terms & condition

1. Eligibility :

- (a) B.Sc. / B.Tech Dissertation : Pursuing graduation in Science / B.Tech or equivalent with consistent good academic record.
- (b) M.Sc./ M.Tech Dissertation : Pursuing M.sc./M.Tech or equivalent with graduation in any discipline.

2. Fee should be paid at the Institute during week days from 09:00am to 05:00pm. in Cash or by Demand Draft drawn in favour of Director, Institute of Forest Biodiversity, Hyderabad payable at Hyderabad. Payment of Fees should be made before commencing the project work
3. No accommodation will be provided by the Institute.
4. The Scientists/ Officers of the Institute under whose guidance students pursue their project work shall be the Guide/ Supervisor and the concerned faculty member in their college /Institution shall be the co-guide or co-supervisor
5. Dissertation of candidates with less than 80% attendance will not be certified by the Guide / Institute and such students shall not be allowed to pursue the work further and project so allotted shall be cancelled.
6. After completion of project work, students are required to present the progress of work in a seminars / arranged by their guide /supervisor before submitting the final dissertation.
7. The dissertation shall bear a certificate duly signed by the Guide / Supervisor of the student and the Director of the Institute or his nominee that the work was undertaken in the Institute and the students has successfully completed the stated objectives.
8. One copy of final corrected version of dissertation bearing signature of Guide / supervisor and Director of the Institute shall be submitted to Institute.
9. All the publications resulting out of the work done in the Institute shall be processed through the Guide / Supervisor in the Institute.
10. The students shall be responsible for the safety of the instruments / lab facilities which they are allowed to use and damages attributed to them shall be recovered from the caution deposit.
11. If the students misbehave, indulge in mischief, damages any property or disturb the tranquillity during their stay in the institute, the allotted project work will be cancelled, fees forfeited and students will be sent back under intimation to their head of institution and parents of the students.
